## **Moving Forward and Ready to Grow**

Dear Members,

he Institute for Credentialing Excellence (ICE) has been hard at work in 2013 expanding its role in the standards community, developing professional development products, and creating more channels for you to gain knowledge on best practices.

Notably in 2013, ICE introduced the newly branded 2013 ICE Exchange with a new format and fresh experience for our annual conference attendees. In an enhanced learning environment, attendees chose from a vast selection of educational sessions, attended the first-ever Learning Lounge – a high energy environment with bite-size learning – and stayed connected with a new mobile application. The event gathered more than 535 credentialing professionals in Amelia Island, Florida– the most in ICE history!

Here are just a few highlights from this year:

- Standards Revision: After nine years, ICE initiated the Standards Revision process in mid-2013. The Main Committee is chaired by Paul Grace and Lawrence Fabrey, with a total of eleven members. Three task groups have been formed to address standards related to administration/ governance, psychometrics, and continuing competence. The timeline for completion of the final set of NCCA Standards is not fixed, but the groups are drafting and revising standards that have been shared with the Main Committee for input and subsequent revision. Next steps will include a public comment period, revision of draft standards as necessary, and final issuance, which is anticipated in second guarter of 2014.
- >> Continued Competence Task Forces: The five subgroups of the Task Force are making tremendous progress with a variety of work products in development. A facilitated Symposium is being planned for Q1 2014 with the emphasis of attracting a wide variety of stakeholders.

The products being developed include:

- » Model framework for continuing competence program
- » Evaluation criteria tool to help organizations plan for a change to their program and/or evaluate their current program
- » An overview of the work of the Task Force was reported on at the 2013 ICE Exchange Closing Plenary.
- Education: ICE is carving out a reputation as *the* provider of professional development opportunities for credentialing specialists and executives. The Governance Workshop drew a sell-out audience in June while the webinar series addressed a variety of topics from *Launching a Certification Program* to *Legal Considerations for Governance* to *Continued Competence*. In addition, the credentialing executive had numerous opportunities to network with and learn from each other.

Looking forward to the New Year, ICE is excited to once again offer a wide range of educational products and engage in new initiatives. Stay tuned to www.credentialingexcellence.org to learn the latest details on what's ahead.

## **Building the Value of Credentialing, Year After Year**

With the dedication of volunteers, leaders, and members, the Institute for Credentialing Excellence (ICE) and its accreditation body, the National Commission for Certifying Agencies (NCCA), continues to support the credentialing community through education, standards, and research. This report highlights the accomplishments of ICE, the NCCA, and its members during the twelve months following November 2012.

### **Education**

### 2013 ICE Exchange Recap

The newly branded 2013 ICE Exchange welcomed with more than 535 industry professionals – more than ever before in ICE history. With a fresh educational format, ICE piloted a variety of new features throughout the event.

Soren Kaplan, founder of Innovation Point, kicked-off the conference with an intriguing keynote address about how it takes a solid understanding of industry trends, customer needs, and new possibilities to create innovative ideas. Kaplan's inspiration left attendees with new insights and new ideas to implement into their day-to-day work.

ICE introduced our Learning Lounge – a dynamic, high energy environment where attendees gathered to engage in bite-size learning opportunities on varied industry topics. The colorful Learning Lounge fostered new opportunities for peer-to-peer learning in roundtable discussions, mini presentations by invited experts, ePoster gallery, and a genius bar. Throughout the event, attendees shared electronic "Aha! Moments" about trends impacting the credentialing industry. Submissions were entered for a chance to win a grand prize. The winning "Aha! Moment" was submitted by Michelle Porter from International Code Council and said: "We should be making public the work, effort, and money we've put into creating valid job task analysis – too much work to keep the results quiet!"

The official 2013 ICE Exchange Mobile App launched a short time before the event, and attendees were able to build their own schedule, network electronically with peers, access speaker handouts, and participate in ICE social media all in the palm of their hand. The ICE staff, volunteers, and industry partners were very happy with the success of the event and look forward to carrying this momentum into the year ahead.

### ICE Academy: Credentialing Education Year-Round

The ICE Academy continued to offer relevant educational opportunities throughout 2013. A major success was the governance workshop held in Washington, DC. Glenn Tecker, Chairman & CEO of Tecker International LLC, facilitated this in-person, full-day, interactive workshop, examining the approaches to governance preferred by elected leaders and staff executives in the credentialing industry. This workshop equipped association staff and board members with the appropriate tools to make more confident decisions, sustain effective partnerships, and earn the support of their stakeholder communities.

ICE continued to offer the Certification 101 online modules, which have been applauded as a core onboarding tool for new employees. The modules have also been used to orient incoming board members to help them better understand the credentialing industry and certification as a whole. In addition, the Credentialing Marketing for Non-Marketing Professionals course continued to be a great resource for small organizations that do not have designated resources or budget for marketing. These permanent online educational offerings provide valuable, ongoing training to credentialing industry professionals, board members, and committee members.

The ICE Academy will add to its live webinar series and online courses in 2014, and introduce a new Executive Education series – CEO Connect. ## **Standards Revision – Looking Forward to 2014!**

The NCCA Standards Revision Project is well under way in its process of reviewing and revising the current NCCA accreditation standards. An update was provided at the 2013 ICE Exchange General Session on Tuesday, November 12. Once drafted and reviewed, the proposed new standards will be released with the opportunity for public comment, with subsequent revisions as necessary. It is anticipated that the new standards will be published in early to mid-2014, with a goal of implementation in 2015.

### The National Commission for Certifying Agencies (NCCA): More Efficient Than Ever with Its Online System!

The new online system for NCCA application, renewal, and annual reports launched this year and has been utilized for the January 31, April 30, and August 31 deadlines. The automated online system has allowed for a smooth application process with greater guidance and resources for applicants and efficient review for staff and Commissioners. As with all newly deployed software, there are always opportunities for additional features and changes, and ICE is continually reviewing and revising the process to improve efficiency.

Notifications are sent via an automated system which allows for documentation of all correspondence and communication regarding applications. A feature has been added so that organizations submitting multiple applications have the option to synchronize their forms so that duplicate information is automatically populated.

The NCCA has maintained its standing as the leader in providing accreditation services to personnel certification programs, having now accredited more than 280 certification programs from over 120 different organizations. The accreditation program continues to grow as more and more organizations seek third-party recognition of their programs.

ICE would like to thank the 2013 volunteer NCCA Commissioners for their tireless effort and commitment to the NCCA.

### Assessment-based Certificate Accreditation Program (ACAP)

The launch of the new accreditation program, ACAP, has reached its one year anniversary! Within the year, 4 applications have been submitted for review. ICE currently offers several tools to help prepare certificate programs for accreditation. Resources include a self-assessment checklist, an instructional design guidance document, the ICE 1100 standards, and the application itself that includes guiding questions to help applicants understand the intent of the standards and types of evidence needed to demonstrate compliance. In 2014, ICE plans to provide additional education opportunities, including a three-part webinar series on instructional design principles to guide certificate program development.
